Hey Wanda, I talked with Brandi Calloway about this situation. She says that I didn't cause Mandi any harm. She says she is 110% sure.

I have beaten myself up over this on and off for going on 2 decades.

I may or may not have told you this, but I was severely sexually abused for years starting somewhere around ages 3 to 5.

I was not the only boy up to this kind of mischief at that age. It was a good half of us or more. And your daughter was a frequent target for the boys around that trailer park, those who lived there as well as those that were visiting other kids.

What made them have this inclination I do not know, but for me I have no doubt that my history of abuse played a big role.

Not one thing that happened with me and her was without consent, but I pressured her, etc. I have still felt like it was something wrong for a long time.

I was so happy when Brandi told

Me that I didn't cause her pain, at least not anything severe or that lasted for a long time. I figured that Brandi is a good source because Mandi confided in her about things.

She would know if anyone did.

I've reached out to your daughter for 7 years. She was talking to me on Facebook as a friend and then I veered towards this topic and she went blank and never talked to me again.

I feel terrible for her and all the hardship she has. I do not have friends on Facebook but she pops up on my recommended friends list all the time and click her name from time to time.

She seems to be really wanting a good life for her and her daughter, and seems to have trouble finding a good man. I know that one time she had said something about being kept from her son.

If there is anything I need to do to make it right by her, all you or she has to do is tell me. I am a tortured person a lot of the time and there is no promise for me to be here on any given day, but while I'm here I will make an effort to do what I can.

I would very much like for her to be my friend to talk on the phone, so that I can help her. I am very good at researching legal matters and in my spare time I could look it up and find out what she needs to do to get custody of her kid. I know a lot about life and how to make it. I am also willing to give her money in the future, if I have somehow hurt her and that is what it takes to make it right. Right now I am almost completely disabled and extremely broke.

There is one that potentially hurt your daughter. It is not rocket science to figure out what I am talking about. It was around the time I was 13. I have confided that this bothers me with more than one person, and given them the details as I recall them. They all pretty much write it off as boys will be boys behavior and say I did nothing wrong, that a million other boys do the same thing.

I am still open to the chance that I have hurt her. I have attempted to reach out to her as well as you probably close to a dozen times. If I have done her genuine harm I will apologize in public or in private, whatever she prefers. I will also do what I can to do something to make it up. My repeated attempts to reach out are increasingly giving me the opinion that everyone thinks there was no excessive wrong done outside of what any other boy has likely done at some point. I will quit breaking my neck to reach out for an apology and let you guys respond. If you say nothing then I will assume that there is nothing that needs to be addressed.

I have nothing to personally gain from this other than peace of mind. It's not about me it's about the people I may have caused emotional pain. It would be in my personal self interest to never mention this again to anyone or make it knowledge among the rest of the public in any way, but I am doing the opposite.

Wanda, I am very thankful for all of the kindness you have shown me. Every hour I was at your house was an hour I was not at mine, and my house was a nightmare seven days a week, quite often. Who knows how much further damage to my mind and emotions was saved from the kindness you and Sandy showed me.

Man Accused of Killing Lawyer Receives a New Attorney

Charged in the murder of his former attorney, Miguel Trujillo has been appointed another attorney from the public defender's office.

Judy Rind, from the Public Defender's Department in Albuquerque, had no comment, saying that she had just been given the case with no time to review it.

Trujillo had recently rejected his previous court-appointed attorney of six months, Marc Rubin.

An attorney from out of dis-

trict was hired because none of the attorneys waiting for U.S. Public Defender's Department cases of Steven Seiden (Case No. 10-18) the man Trujillo is accused of murdering in a drive-by shooting.

Vigil was murdered Aug. 13, 1999, a few blocks from his South Street office while waiting to District Court for a hearing.

A five-page, early report filed pickup was quoted in the area looking Trujillo for the crime. Assistant District Attorney Richard Schuler said the court was waiting for an attorney to represent Trujillo to be found to

schedule the new hearing.

All Five District Court judges were disqualified from the hearing, with Judge Douglas M. Miller excused. The Supreme Court appointed Second District Court Judge Neil Condit to hear the hearing.

Trujillo is accused of an open charge of murder, two counts of extorting a witness at witness, one charge of tampering with evidence, and one charge of being a felon in possession of a firearm.

Trujillo paid \$50,000. He faces up to 99 years in prison.
